## Warrigal Update

Dear resident representatives and relatives

The past week has seen an increase in the number of Australians receiving the COVID-19 vaccine, with over 1.3 million now vaccinated, compared to 920,000 last week, including more than 158,000 residents in aged and disability care homes. While the Government is reviewing the roll-out of the COVID-19 vaccine in light of last week's announcement from the Australian Technical Advisory Group on Immunisation (ATAGI) that the Pfizer vaccine is preferred over the AstraZeneca vaccine for adults aged under 50 years, there has been no change to the arrangements for aged care residents with the rollout of the Pfizer vaccine continuing.

The Australian Government has released a fact sheet on the importance of having the vaccination as the best protection, the need to make an informed decision particularly as we are now heading into winter, and the risks of transmission will increase. I have attached the fact sheet for your information.

Today, our largest Care Home at Goulburn received the first dose of the COVID-19 vaccination, where 144 residents received the vaccine through Aspen Medical. With only Bundanoon remaining, this means that we now have 919 residents at Warrigal that have been administered with the first vaccine, while 106 residents have either chosen not to receive the vaccination or could not receive it due to a medical condition or being on respite and were not going to be there when the second dose was administered. This means that close to 90% of the residents at Warrigal have been vaccinated.

The table below has been updated to reflect those where the doses have been completed.

This week the relative meeting for Albion Park Rail provided some valuable feedback on the communication being sent, and the concerns that staff taking unplanned leave are not always being replaced despite every efforts by the roster team to ensure that there is always a full complement of staff working. This is similar feedback that we have received for other homes, and we are looking at increasing the number of casual staff available to provide support to the core roster. It was also discussed at the meeting that concerns raised over attracting staff to aged care was consistent with a number of recommendations in the Aged Care Royal Commission, and also one of the key drivers of the campaign that was mentioned in a previous update seeking your support in signing an online petition for more funding to the sector in the "Care About Aged Care Campaign". In these relative meetings, the accreditation process has also been discussed, where the current standards that were implemented back in July 2019, Standard One, is focused on "Consumer Dignity and Choice". There are six different requirements under this Standard, and the first one is that "Each consumer is treated with dignity and respect, with their identity, culture and diversity valued". In order to achieve this our staff need to explore the individual needs, goals and preferences and where necessary utilise interpreter services of specialist agencies.
